It is fully my responsibility to have all ADSL equipment operational prior to the ADSL connection. DataCorp reserves the right to configure any ADSL related equipment for use on their network. It is my responsibility to have a telephone jack for the ADSL service near my computer or workgroup hub, and that any extra wiring that will be required is not the responsibility of DataCorp. I/We authorize DataCorp to automatically debit credit card, once per month in advance of that month's access charge, plus any additional costs incurred in previous months, in excess of the fixed package flat rate, such as excess traffic charges.
